***Award Conditions to the Financial Assistance Award
Between the Denali Commission and Bristol Bay Borough
For Port of Bristol Bay Construction
Award No. 1062, Amendment 1
July 2009***

All changes to the award conditions are noted below.

1. Scope of Work

This amendment increases the funding amount listed in the original award documents. The total increase is \$700,000 in FHWA Section 129 funds, thus increasing the total award funding to \$1,700,000.

This amendment also corrects the other contributing funds as follows:

- The correct amount for Bristol Bay Borough is \$2,427,092;
- The correct amount for the State of Alaska is \$2,400,000;
- and the correct amount for the Economic Development Administration is \$1,544,762.

There are no other changes to the original Financial Assistance Award, as amended.
