1. Award Conditions - Close out of Nenana 9th and K Streets Reconstruction

***Award Conditions to the Financial Assistance Award  
Between the Denali Commission and Nenana Village Council  
For Nenana 9<sup>TH</sup> and K Streets Reconstruction Phase II  
Award No. 1040, Amendment 2  
March 2010***

All changes to the award conditions are noted below.

***1. Scope of Work***

This amendment closes out the award and de-obligates a total of \$1,427,424 in FHWA Sec 1960 Roads funds (\$627,424 of FHWA 1960 09, and \$800,000 of FHWA 1960 08). The purpose of the deobligation of funds is to set up a transfer of responsibility for design and construction management with the FHWA Western Federal Lands Highway Division (WFLHD). Deobligation is a necessary step in the project reassignment. Reassignment is necessary to ensure the project is developed in full compliance with Title 23 CFR.

Funds deobligated under this action will be assigned to WFLHD under a new agreement.

There are no other changes to the original Financial Assistance Award, as amended.
