All changes to the award conditions are noted below.

1. Scope of Work  
 This amendment provides an increase of \$138,813 in FY09 FHWA Section 1934 funds to the North Pacific Rim Housing Authority (NPRHA) for the subject project. The NPRHA is providing \$12,535 in required match funds through its overall project. The increase is a result of escalating construction costs for remote site construction. This increase will complete the scope of work as originally awarded.
