REMARKS:

Award Conditions to the Financial Assistance Award Between the Denali Commission and Department of Transportation & Public Facilities For Emmonak Community Road Improvements Award No. 230-06, Amendment 5

All changes to the award conditions are noted below.

1. Award Performance Period

The amended Award performance period is May 23, 2006 through December 31, 2016. This is the period during which Award recipients can incur obligations or costs against this Award.

The purpose of the amendment is to allow time for the ADOT contractor to complete two ADOT&PF projects: Emmonak Community Road Improvements, and Emmonak Landfill Road. These projects were packaged into one contract. There is also a Landfill Relocation project being managed by the City of Emmonak with consultation by DOWL HKM. All three projects are contracted with Bering Pacific Construction. Completion of all three projects is scheduled for October, 2015. The request to extend to December 31, 2016 will allow final invoicing and payments to take place.

There are no other changes to the original Financial Assistance Award, as amended.
