All changes to the award conditions are noted below.

***1. Scope of Work***

This Amendment allocates funding in the amount of \$104,087 to new projects as listed in Table A. Funding in the amount of \$90,000 is reduced from Project #06-4-C-5020 New Stuyahok: Domestic Violence making the balance of that project \$0.00. Funding in the amount of \$14,300.78 is reduced from Project #0136-DV-Pool Statewide: Domestic Violence Pool leaving a balance of \$0.00. Funding in the amount of \$12,000 is reduced from Project #06-4-C-5114 Dillingham: Domestic Violence Shelter Construction - 2nd Floor leaving a balance of \$0.00. The total of these actions is \$116,300.78 and is allocated to projects in Table A. The DHSS shall be responsible for working with the Council on Domestic Violence and Sexual Assault (CDVSA) in granting funds to recipients listed in Table A.
