1. Scope of Work

The Denali Commission (Commission) is providing a total of \$4,000 to the Alaska Energy Authority (AEA) for the sponsorship of the 2007 Alaska Wood Energy Conference as approved by the Commission. The Conference will be held November 14-15, 2007 at the Chena River Convention Center in Fairbanks, Alaska.

The conference provides a means for people throughout the state to consider ways to use a major local source of renewable energy that hold potential for displacing diesel fuel, reducing and stabilizing energy costs, stimulating local economic development, lessening potential for fuel spills, and reducing air pollution and greenhouse gas emissions.

Commission funds will provide a prominent venue for demonstrating Commission support for alternative energy in a statewide conference, including an address to the full conference attendees by Federal Co-Chair George Canelos as a keynote speaker at this event. Funding will also be used to support speaker travel and lodging and conference incidentals.

As a sponsor, the Commission's name will be recognized throughout the conference and on all conference related materials.

The Commission will receive any contact information provided for attendees via electronic format.

The Commission will receive a summary report of the event, which will include conference agenda, handouts, photos, and the number of attendees.

Commission funds for sponsorship can be used for: event space and equipment rentals for the actual event, event costs including video, audio and sound system rentals/services, travel of conference attendees (travel does not include food costs), event brochure printing or other event media needed for attendees. All activities that involve the work of consultants or contractors must be procured through fair and open procurement processes, in keeping with the Federal Circulars in order to be eligible Commission costs.

Commission funds cannot be used for food or beverage of any kind, gifts, per diem of attendees or wages/salaries. Any questions regarding acceptable uses of funds should be directed to the program manager.

All Commission funding is intended for use for the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Commission.
