**1. Scope of Work**

The Denali Commission (Commission) is providing a total of \$25,000 to the National Association of Development Organizations (NADO) for sponsorship of "NADO's 2008 Annual Training Conference: North to the Future" to be held at the Hilton in downtown Anchorage, Alaska October 3 - 7, 2008.

The conference expects approximately 600 community and economic development professionals serving primary rural and small metropolitan regions to attend the conference.

The proposed investment will address regional strategies for economic development and specific topics related to professional development and organizational enhancement. The conference will include peer exchanges, best practices and other professional training for regional development organizations.

The end result is to provide training to executive leadership and staff of regional development organizations and others engaged in rural development that will help them enhance their capacities to manage programs that bring economic strength and success to their regions, particularly rural and distressed communities. The combination of peer exchanges/best and noteworthy practices with industry experts will provide opportunities for attendees to learn about strategies and approaches that may be replicated in their regions as they strive to resolve community and economic development challenges.

A portion of the funds requested will be used to help cover costs for individuals from Alaska to attend the national conference, individuals who might not otherwise be able to attend. Assistance will be made to individuals who are currently working to strengthen their communities with support from the Commission and the training and information they will receive during the conference will be beneficial to the overall success of their Commission investments.

Funds will also be used for various mobile workshops aimed at showcasing successful community and economic development initiatives. NADO will work with Mark Allred to showcase at least one Commission noteworthy project for attendees to gain an appreciation of how the Commission works throughout the state to build communities and economies; it will also be an opportunity to learn about the inherent challenges to project development in Alaska.

Commission funds of \$25,000 for the Conference will provide some of the following:

- Recognition on NADO website
- Print in conference materials including program and verbal recognition in welcoming address
- Booth space
- Banner space
- List of conference attendees with contact information
- An opportunity by the Commission to announce/discuss our ten year anniversary both through print mediums and speaking opportunities.
- Speaking opportunity for George Canelos, Federal Co-Chair of the Commission.

Commission funds for sponsorship can be used for: event space and equipment rentals for the actual event, event costs including video, audio and sound system rentals/services, travel of conference attendees (travel does not include food costs), event brochure printing or other event media needed for attendees. All activities that involve the work of consultants or contractors must be procured through fair and open procurement processes, in keeping with the Federal Circulars in order to be eligible Commission costs. Commission funds cannot be used for food or beverage of any kind, gifts, per diem of attendees or wages/salaries. Any questions regarding acceptable uses of funds should be directed to the program manager.

All Commission funding is intended for use for the scope of work identified in the Award document only. Any balance of funds remaining after the full scope of work has been completed will be returned to the Commission.

**3. Award Performance Period**

**7. *Project/Award Close-Out***

The project close-out report shall be completed within 90 days of the end of the Award performance period or within 90 days of the completion of the project, whichever is earlier. Recipients must also draw down any remaining funds for expenditures incurred under this award during this 90-day period.

The project close-out report shall be submitted on-line through the Commission's on-line Project Database System, available at [www.denali.gov](http://www.denali.gov). The project close out will require the recipient to submit the following information:

- a. Final project expenditures itemized by the following categories: planning & design; materials & equipment; freight; labor; project administration/overhead and other expenses.
- b. Acknowledgement of support: For all non-construction projects, the Award recipient shall include an acknowledgement of the Government's support for the project(s) developed under this Award. The format for acknowledgement of the Government's support for non-construction awards will vary with each award and must be agreed upon between the Award recipient and the Commission Project Manager. See the Scope of Work for acknowledgements to the Commission. Costs associated with this

requirement shall be paid out of the project funding received by the Award recipient from the Commission.

**8. *Public Policy Laws and Assurances***

Award Recipients are required to comply with the public policy laws and assurances on Standard Forms SF 424b (non-construction projects). This form must also be signed by a certifying official of the organization. Some of the laws are highlighted below for your reference.

**9. *Non-Compliance with Award Conditions***

Recipients not in compliance with the terms and conditions of this Financial Assistance Award will be notified by the Commission. The Commission will work with the recipient to identify the steps necessary to bring them back into compliance, and will establish an appropriate time frame for the corrections to be made. If the corrections have not been made by the deadline, the Commission reserves the right to either suspend or unilaterally terminate the Financial Assistance Award for non-performance.
